

Family Separation Allowance (FSA)

- ✓ Payable to member w/dependents and Mil to Mil
- ✓ Amount payable \$250
- ✓ Types of FSA
- ✓ FSA-T
 - Away from PDS continuously for more 30 days
 - Member's dependent(s) do not reside at or near the TDY location
- ✓ [DoDFMR Vol 7A Chap. 27](#)
- ✓ **Documents Needed:**
 - DD1561,
 - DD1610 or DTS Authorization w/six-digit authorization number



NOTES:

Hardship Duty Pay (HDP)

- ✓ Types of HDP
 - HDP-L (Location) Max \$150
 - HDP-M (Mission) Max \$150
- ✓ HDP-L
 - Payable to mbrs deployed over 30 days
 - Ends on the day the mbr departs the payable station
- ✓ If mbr receives HF/IDP, then maximum amount of HDP-L is \$100
- ✓ Total entitlement of HDP-L plus HFP/IDP in any 1 month may not exceed \$325

- ✓ **Documents Needed:**
 - Fill out DD1610, or
 - Orders and travel voucher *

Hostile Fire/Imminent Danger Pay (HF/IDP)

- ✓ HFP is paid at the rate of \$225 per month (not prorated) when:
 - Subjected to hostile fire or explosion of hostile mine
 - On duty in an area in close proximity to a hostile fire incident and exposed to the dangers experienced by others members subjected to hostile fire
 - Killed, injured or wounded by hostile fire
- ✓ **Document Needed:**
 - Certified by the appropriate commander (AF 1881)
- ✓ IDP is payable on a prorated daily basis not to exceed monthly rate of \$225 (more than 30 days)
- ✓ **Document Needed:**
 - DD1610 or DTS Authorization w/six-digit authorization number

Combat Zone Tax Exclusion (CZTE)

- ✓ Maximum CZTE equals the sum of the highest rate of enlisted basic pay
- ✓ LES remarks on CZTE wages earned
 - March, June, September and December
- ✓ Who is entitled?
 - Designated to a Combat Zone
 - Direct support to a Combat Zone, and receives HF/IDP
- ✓ [DoDFMR Vol 7A Chap. 44](#)
- ✓ **Documents Needed:**
 - Member's orders authorizing to enter QHDA or Combat Zone
 - Travel voucher w/commander's certification that the member performed duty w/in QHDA* or Combat Zone

Savings Deposit Program (SDP)

- ✓ Deposit will not exceed \$10K
- ✓ Multiples of \$5
- ✓ Interest 10% annually, compounded quarterly 2.5%
- ✓ Accrued interest up to 90 days after departing AOR
- ✓ [DoDFMR Vol 7A Chap. 51](#)
- ✓ **Documents Needed:**
 - Fill out DD2558
