I. TRAVIS AFB UPDATES

A. ADMINISTRATIVE

Travis RPM started the meeting and reviewed the agenda. Ms. Constantinescu of the San Francisco Bay Regional Water Quality Control Board introduced her colleague, Mr. David Elias, Mr. Alberto Gutierrez introduced himself as the acting PM for DTSC.

2. Action Item Review (Attachment 2)

Travis RPM reported on the status of action items from the January 2024 RPM Meeting. Please see Attachment 2 for full briefing.

3. Master Meeting and Document Schedule Review (see Attachment 3)

The Travis AFB Master Meeting and Document Schedule (MMDS) was discussed during this meeting (see Attachment 3).

Travis AFB Annual Meeting and Teleconference Schedule

The next RPM meeting is scheduled for 17 July 2024 at 1000.

The next Restoration Advisory Board (RAB) meeting is scheduled for 16 April 2025 at 1900. This is the third Wednesday of April; the venue informed our team that they can no longer accommodate our usual schedule. The RPM meeting will be held on the same day as the RAB (16 April 2025).

B. CURRENT PROJECTS

1. PFAS Update (Attachment 4)

Travis RPM reported on the PFAS updates for Travis AFB. Please refer to Attachment 4 for the full briefing. Highlights of the discussion are as follows:

- Travis RPM discussed other PFAS initiatives. For the NFA-1 contract, the Air Force is working on Agency RTCs but all sites are recommended to move forward to the RI phase. Travis RPM are working to add the sites to the current RI. If the sites can't be added to the current contract, the document schedule or amendments would need to be considered.
- During the November 2023 RPM meeting, Jessica Faragalli briefed that Travis AFB was selected as one of seven installations planned in a nationwide project for PFAS fingerprinting and background study project. Travis RPM asked Ms. Duley to provide an update. Ms Duley discussed a slide outlining the planning documents and upcoming field activities planned for 28 May – 14 June 2024. The field effort will include soil, groundwater, and surface water sampling. The planning documents include a Programmatic UFP-QAPP that is used across all installations included in the study, which will be accompanied with installation-specific addenda. The programmatic UFP-QAPP has already been reviewed by the USACE, AFCEC, and USEPA. The team is not seeking comments on the programmatic document, but plans to submit the Travis AFB UFP-QAPP Addendum tomorrow for regulatory review. The Air Force requests a 30-day review and hopes to work together for accelerated comment resolution to meet the field schedule. Travis AFB will be the first installation to start field sampling activities with the other six installations following closely with staggered timing to manage laboratory capacity. At this time, there is not another time option for this calendar year. Ms. Duley proposed using the 15 May 2024 placeholder meeting to discuss and resolve document comments if reviews could be done in that timeframe to keep on field schedule. Travis RPM asked agencies to prioritize this document review if there are conflicts with other Travis documents since it is a nationwide study with multiple installations on a tight schedule.
- Ms. Constantinescu asked about ecological receptors protection during the field event planned for the fingerprinting and background analysis project. Travis RPM said they work with the 60 Civil Engineering (CE) biologist and follow requirements in the Installation Natural Resources Management Plan (INRMP); if there are concerns in particular areas then mitigation and conservation measures are followed. Ms. Constantinescu asked if the base biologist will be in the field during sampling; Ms. Duley replied that an Oneida biologist will be onsite and will follow the same process and mitigation measures as for the RI.
- Ms. Duley took the action item to flesh out the schedule for the AFFF RI, in addition to other forthcoming documents under the PFAS remedial investigation contract, to Ms. Royer to include in the MMDS. All Oneida documents will be discussed as part of Oneida's update in future RPM meetings.
- Travis RPM noted that the USEPA published MCLs for five PFAS constituents, and that they are waiting for guidance from AFCEC and the Office of the Secretary of Defense, but are reviewing previous data from off-base private drinking water wells.

2. LUC Updates (Attachment 5)

Travis RPM reported on the status of the LUC sites at Travis AFB. Please refer to Attachment 5 for the full briefing. Travis RPM mentioned that the funding to accomplish the indoor air sampling at the KC-46 Hangar is not through the Environmental Restoration Program, it is through the ROICC. Leadership is aware of the situation and is working on a solution.

Travis AFB Phase I RI of PFAS Sites – Program/Issues/Update (Attachment 8)

Phase 1 Remedial Investigation Data-Driven Process

Ms. Duley presented a diagram illustrating the current progress and upcoming activities as part of the data-driven process for the Phase I RI. Data being generated from Field Event #3 is being integrated with previous field data for use in the ESS, CSM, and Phase I RI Report. The Final Phase I RI Report is currently due in July 2025, which is the end of the current contract. AECOM is currently developing ESS cross sections, which will be included in the ESS Tech Memo to be submitted in the summer/fall of 2024. Adriana noted that the ESS Tech Memo is not included in the MMDS. Ms. Duley will compile the Phase I RI Report and ESS Tech Memo dates and send to Ms. Royer for inclusion in the MMDS.

Current Status/Next Steps

Ms. Duley provided an update on the Current Status slide providing the dates for project milestones and completion of field work events. Eight lysimeters were installed and sampled in September 2023 and again January 2024. The third sampling event was performed this week and the fourth and final sampling event is planned for July 2024. The team noted the need for additional monitoring wells to address data gaps. Travis RPM noted that the Air Force is currently pursuing options. Ms. Constantinescu noted that property access issues were a consideration when selecting initial monitoring well locations (i.e. located along roadways). She noted that since securing the access agreements would likely be more timely, locations can be based more on the geologic and hydrogeologic

conditions. Ms. Duley agreed and noted that the well locations from Field Events #2 and #3 did provide valuable step-out locations. Ms. Duley showed a map of lysimeter locations. Lysimeters were installed at AFFF Sites 5 and 6 and are currently sampled quarterly.

Ms. Duley summarized next steps: the updated ESS Tech memo updated will be provided summer/fall 2024, the final lysimeter event will be conducted in July 2024, and the Phase I PFAS RI Report will be submitted in 2025.






Field Event #3 Completed Locations










Lysimeter Locations







Lysimeter Quarterly Sampling





- Similar construction to a monitoring well
- Pressure is applied to the black tube
- Leak check through the green tube
- Sampling pore water through the white-clear tube
- Approximately one 500mL HDPE bottle of water per lysimeter
