# Qualities of followership hold importance

As the Air Force has gotten progressively smaller in recent years, the process for how we grow and develop our future Air Force leaders has become extremely important.

The topic of developing leaders is a frequent discussion point at wings, groups and squadrons across the Air Force. However, one of the key elements of leadership development that is often overlooked is the concept of followership. Strong followership skills are fundamental to leadership.

According to the Merriam-Webster Dictionary, followership is defined as “the capacity or willingness to follow a

leader.” However, the complexity and benefits of followership go way beyond its accepted definition.

Regardless of your rank or specific role in accomplishing the Air Force’s mission, each of us juggle the roles of leadership and followership. So, what exactly are the followership skills that are so important in today’s Air Force?

From my perspective, there are three skills that I most value in relation to followership. Those skills are the individual’s ability to execute their designated job or specialty, adaptability in the face of challenges and a heavy dose of resiliency.

First and foremost, the most

fundamental followership trait is learning and mastering your given job specialty. In 2016, as the squadron commander of the 5th Expeditionary Squadron in Kuwait, I was privileged to lead several rotations of aircraft maintainers and air transporters in the deployed environment.

During that year, a team of eight aircraft maintenance personnel, from the ranks of staff sergeant to major, along with a Boeing representative, identified a repetitive issue with the anti-collision light systems of C-17 Globemaster III aircraft traveling in and out of the area of

responsibility. The lights were returning to home station with severe cracks after traveling in and out of some of the region’s harshest airfields.

In response to the challenge, the team developed an innovative taping solution utilizing inexpensive, clear polyurethane tape to reinforce the lights on each of the assigned C-17s. This simple solution kept the aircraft in service and saved the Air Force hundreds of thousands of dollars.

Each of the individuals involved were some of our most skilled technicians in the unit. Their professionalism and technical expertise identified and implemented an effective and inexpensive strategy that kept the mission moving while increasing aircrew safety. Ultimately, the mission is our No.

1 priority, thus job proficiency will always be a big part of a strong followership model.

Another key to strong followership is adaptability. Change has been constant for the Air Force since its inception as a separate service in 1947. Some of that change and evolution is due to political climate, others to technological improvements.

Either way, our ability to adapt to change is at the heart of what makes us the world’s greatest Air Force. To me, Viktor E. Frankl, the famous Austrian psychologist and Holocaust survivor best described adaptability, when he said, “When we are no longer able to change a situation, we are challenged to change ourselves.”

Over the past couple of weeks, several of my Airmen have lost a parent or guardian.

Regardless of whether the loss of a loved one is expected or unexpected, the pain, sorrow and heartache you experience is real.

Many of you have already experienced the loss of a loved one in your life and it is never easy. In 2013, out of the blue, my mother, 62, was diagnosed with a rare lung cancer and was given a short time to live. She was not a smoker nor had she really

Sure, most of us tell our parents or guardians “thanks” as we go about our busy lives, but do you or have you taken the time to sincerely and deeply express how much you

# 22nd AS provides lifeblood of Air Force

A C-5M Super Galaxy assigned to the 22nd Airlift Squadron conducted a Pacific channel mission March 4-11 delivering cargo to Yokota Air Base, Japan, and Osan AB, South Korea.

The mission delivered more than 161,000 pounds of cargo and brought passengers to the Pacific theater.

“Most of the cargo brought to Yokota AB and Osan AB will either be staying there or forward deployed throughout the Pacific region,” said Capt. Brett Boudreaux, 22nd AS C-5M pilot and aircraft commander for the mission. “We’re taking assets from the (continental United States) and delivering them to the Pacific region, enabling the Pacific Air Force mission.”

Since the new ‘M’ model upgrades, the C-5M can now fly direct to Yokota AB without the need to stop at either Joint Base Pearl Harbor-Hickam, Hawaii, or Joint Base Elmendorf-Richardson, Alaska. The aircraft can also make the trip without the need to be refueled by a tanker, this saves time, money and aircraft for the Air Force.

“The channel completely changed when we got the M model,” said Boudreaux.

The 22nd AS flies Pacific channel missions routinely – approximately three per month. Each mission is vital in projecting strategic power in the Pacific region.

“PAC channel missions are the lifeblood of the Air Force,” said Capt. Scott Robinson, 22nd AS C-5M pilot. “While it may not be a glamorous mission, it

keeps the Air Force moving. For anyone who has moved overseas, they know how important it is to get their unaccompanied baggage on time.”

Robinson added that most unaccompanied baggage are pots, pans and other essential supplies, such as clothing and uniforms for military

personnel and their families.

“It’s items that arrive ahead of the individual so they can live and sustain their family while waiting on their household goods to arrive,” said Robinson. “It’s important it shows up on time so personnel don’t have to go buy new uniforms or dishes.”

The C-5M does more than just fly unaccompanied baggage. Most of the items moved by the C-5M are to help out the Army and Navy.

As a Transportation Command asset, the 22nd AS supports anything the Department of Defense needs moved, said Robinson.

“The Army has oversized trucks and helicopters that wouldn’t otherwise be able to be shipped,” said Boudreaux. “They need them fast and the C-5M can strategically place them faster than any other airframe. It is because of the weight we can take off with, as well as our range without needing to aerial refuel that makes the C-5M vital to the PAC channel mission.”

Prior to heading back to Travis AFB, California, various cargo, including a main rotor blade for a Navy SH-60 Seahawk and more than 14 pallets of unaccompanied baggage for service members being reassigned to their next duty stations, were on-loaded to be delivered back to the United States.

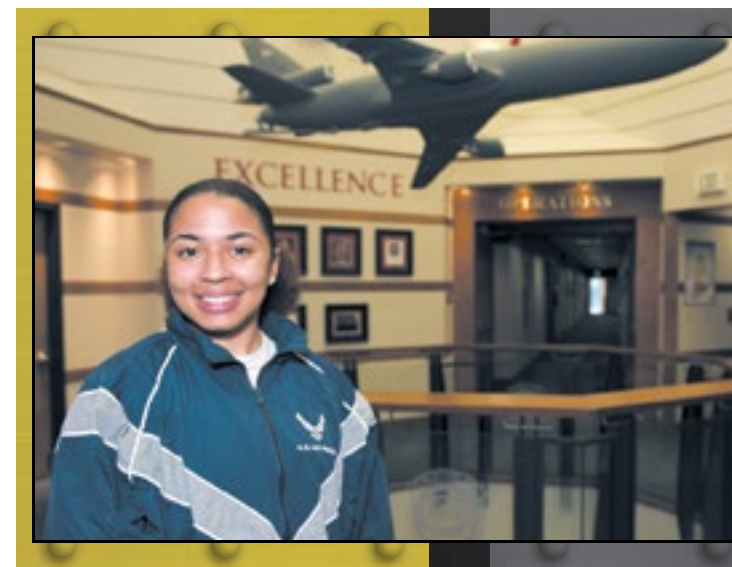

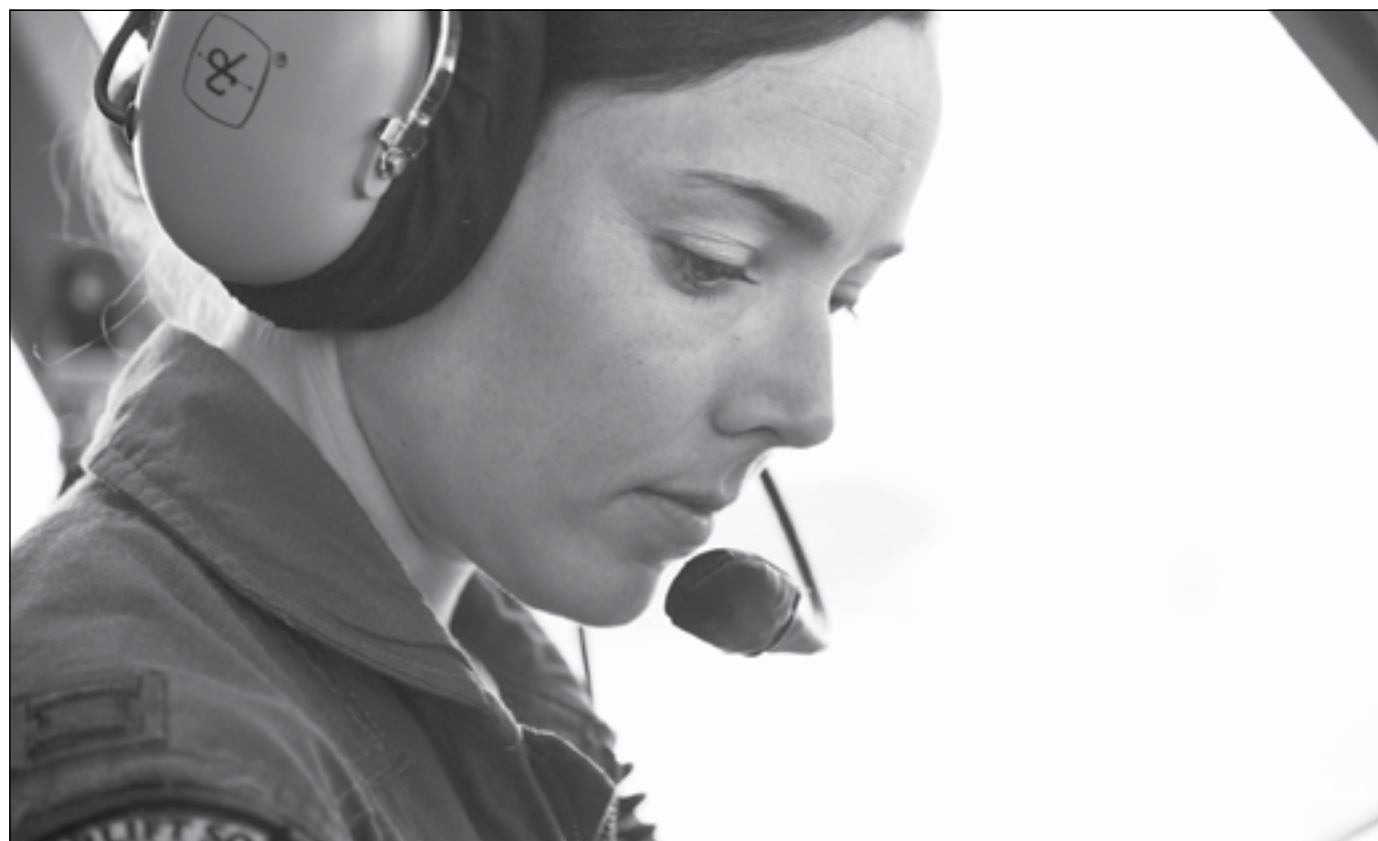
I am extremely proud to serve in an Air Force that values the individual contribution of every Airman regardless of career field, rank, race,

# Officer follows mother's trail

With childlike wonder she watched as her mother pulled on a pair of combat boots. She witnessed her mother forge forward, knocking down walls that once stood to stall female progression.

In the wake of that advancement, there was a maneuverable route the young girl could use to reach her own future goals.

Capt. Jamie LaRivee, 21st Airlift Squadron C-17 Globemaster III pilot, saw her mother as a role model and watched her excel in an Air

Force career, making LaRivee certain she would follow in her mother's boot steps.

"She was in the first class of women at the Air Force Academy," said LaRivee. "That was a big piece of her life that shaped her completely, but it was also a big piece of my life, too."

After LaRivee graduated high school, she mirrored her mother and attended the Air Force Academy where she majored in operations research and minored in German.

Her mother was a rarity as a female cadet in 1976.

# Citizen Airmen save life of drowning child

They didn't set out to be heroes, nor did they expect that their recent temporary assignment to Talafofo, Guam, would place them in that situation.

On Feb. 25, Staff Sgts. Rochelle Waters and Dante Thomas, 349th Security Forces Squadron members, were enjoying an off day at the beach from their training at Cope North when something odd in the water caught their eye.

"We swam all morning," Waters said, describing the scene. "We were just hanging out after our barbecue. I was sitting under a canopy relaxing. Dante was chatting on the phone."

A young boy and his sisters were playing in the water,

swimming, Dante said. As they swam farther out in the water, the boy started to lag behind.

"I don't know why I looked up," Waters said. "I saw the boy, about my son's age, dipping under water, starting to flail and shouting, 'I can't swim, I can't swim, I can't swim.'"

At that point, she started for the water just as Thomas threw down his phone. They both rushed toward the boy.

"As soon as I saw him bob, I knew he was in trouble," Thomas added. "As I was jumping in,

she dove in right beside me."

"I 'Baywatched' it," said Waters. "I stripped down to my suit and dove in. We swam out around 50 yards. I don't remember who got to him first."

Fortunately, both citizen Airmen have life-saving professions outside of their Reserve careers: Thomas is a police officer, Waters is a nurse.

Once they got the boy to shore, Waters noticed the child's lips were blue and knew

# Despite state law, marijuana illegal for military

Following California's recent decision to legalize recreational marijuana, the Air Force Office of Special Investigations wants to remind military members that marijuana possession, use and distribution are still illegal under federal law and any violation could be career ending.

California's Proposition 64, also known as the Adult Use of Marijuana Act, made it legal for individuals 21 years or older to possess and grow marijuana for personal use as of November 9, 2016. That is the California state law. Air Force members

serve under federal law, where marijuana is still an illegal controlled substance. Per Department of Defense Instruction 1010.4, "substance use is incompatible with readiness, the maintenance of high standards of performance, and military discipline."

"We need to remind our military members that it is still illegal to use marijuana and such use may result in court martial under the Uniform Code of Military Justice and/or discharge under Air Force Instruction 36-3208," said Col. David Western, 60th Air Mobility Wing Judge Advocate.

"Seventeen OSI investigations in 2016 involved the use, possession, and/or distribution

of controlled substances from Travis Air Force Base Airmen," said Special Agent Vanessa Galvan, AFOSI Detachment 303 commander.

The maximum punishment under the UCMJ for wrongful use of marijuana is a dishonorable discharge, forfeiture of all pay and allowances and five years confinement.

Marijuana use is illegal regardless of the circumstances behind the use. Some military members believe they can use marijuana provided they have a valid prescription from a doctor, often known as a medical marijuana card. However, the Air Force does not recognize medical marijuana, and any use of medical marijuana

is still considered wrongful use for military members.

Airmen should also be cognizant of use or possession by spouses and friends, particularly when sponsoring them on base. Military bases are federal property and, as such, subject to federal law.

"Visitors assume state law is applicable throughout the state," said Lt. Col. Joseph Quinn, 60th Security Forces Squadron commander. "Although true in some instances, not the case when it comes to marijuana. Marijuana is illegal on all federal installations even if the person has a medical marijuana card. When sponsoring visitors onto the installation, we

rely on our base residents and work force to advise guests of this policy and facilitate compliance to the best of their ability."

Civilians who live on or visit Travis Air Force Base, California, may not have marijuana on their person or in the car. Introducing marijuana onto a military installation is a federal offense, even if the possession would be legal for him or her anywhere else under California law.

# Flight challenges squadrons at Travis to become healthier

“Healthy Habits Happen Here” is the slogan for a squadron challenge sponsored by the Health Promotions Flight at Travis Air Force Base, California.

The challenge is designed to help military and civilian Airmen “take responsibility for improving their own health,” said Mary Nelson, 60th Aeromedical and Diagnostic Squadron Health Promotions Flight commander and registered nurse at the David Grant USAF Medical Center.

Each squadron is encouraged to select an area for improvement. For example, a squadron could commit to increasing the number of steps members walk or the amount of water they drink daily. Participants also could choose to get more sleep and reduce stress levels, said Nelson.

“It’s not about making big

changes, but it should be some area that people want to improve,” said Nelson, a registered nurse with a doctorate in research.

Before beginning the challenge, a squadron representative will meet with Nelson to design a program and outline the rules of engagement. Unit participants will then enroll in the program for a six to 10 week period and begin recording their progress.

The competition runs through December, so organizations can pick a timeframe to begin the challenge.

“Airmen compete within their squadron to make a bigger change than their competitors, but it does not end there. Each squadron will be judged by a qualified panel at the end of the year to see who had the most innovative program, enrolled the most participants and had the best outcomes,” said Nelson.

The panel will decide the winning unit and award a plaque that will hang in the 60th Air Mobility Wing building. Active-duty members of the winning unit who participated in the challenge will get a day off, said Nelson.

“Health promotion is not about classes, health fairs and wishful thinking but rather it is about action and incremental changes to develop healthier habits,” said Nelson.

# Chief seeks to put people first

WASHINGTON — When Chief Master Sgt. of the Air Force Kaleth O. Wright received the title of the Air Force's most senior enlisted Airman less than a month ago, he instantly became responsible for advocating the best interests of more than 398,000 total force enlisted Airmen and their families.

Wright shouldered that responsibility as he testified before the House Appropriations Subcommittee on Military Construction and Veterans Affairs and Related Agencies regarding the Air Force's quality of life March 8.

"The ultimate source of air, space and cyberspace combat capability resides in the men and women of the U.S. Air Force," Wright said. "We must put them first as they face the challenges inherent in serving in the profession of arms."

During the hearing, Wright updated the subcommittee on the welfare, readiness and morale of Airmen. He answered questions on specialty credentialing, critical infrastructure projects, concerns within the Defense Department school system and the Exceptional Family Member Program.

Wright said, in order to meet global demands, resource emerging requirements, and repair and sustain the force, the Air Force must increase its active-duty personnel from 254,000 to 321,000 this year.

"We are the smallest Air Force that we've ever been, and there are many

challenges that come with the high ops tempo and the multiple deployments to the many places we help defend around the globe," Wright said. "That's why the increase we're trying to get to is critical."

Pay and compensation uncertainties are

## 'God clause' in oath is optional

Over the past year, I had the honor of administering the Oath of Enlistment for three Airmen at Travis Air Force Base, California.

These sergeants swore to support and defend the Constitution of the United States, to bear true faith and allegiance to the same and to obey the orders of the president of the United States and the orders of the officers appointed over them.

They ended their oaths with, "So help me God." While not an issue for my re-enlistees, this final clause has been challenged by others who argued it violated their First Amendment rights.

In the armed forces, where good order and discipline as well as mission effectiveness must be considered, issues involving perceived government entanglement or forced religious acceptance are complicated further. Thus, claims of First Amendment infringement must be addressed carefully. As it stands today, all officers and enlistees may opt out of the "God clause," but this decision was by no means a fast or simple one.

What made this issue different than a public prayer or mention of God is that it was a requirement as opposed to a voluntary action for the individual. Since all service members are required to make an oath, and all oaths requiring an affirmation of God are contrary to the deeply held beliefs of some service members, then a secular oath option must be given.

This reasoning is how the

# How mail gets to the area of responsibility

SOUTHWEST ASIA — Deployments have changed over the years. It's now easier than ever to stay connected with loved ones back at home through video chats and messenger applications, but there still isn't anything quite like receiving a hand-written birthday card or a care package with a favorite homemade snack. In fact, mail calls are important for boosting morale.

Getting these letters and packages to the 386th Air Expeditionary Wing not only requires covering long distances, but also includes the concerted efforts of a variety of locations and units.

Before the mail even arrives in the U.S. Air Forces Central Command area of responsibility, the 609th Air Communication Squadron, an AFCENT tenant unit, works as a liaison between the post office and the host nation's customs agency to ensure the incoming mail makes a smooth transition to its

destination, explained Tech. Sgt. Melissa Cervantes, the 609th ACOMS mail control activity chief.

"We perform quality assurance on Department of Defense United States Postal Service mail movement contracts and monitor 450 plus flights annually while providing government oversight and verification of contractor weighed and built pallets," Cervantes said. "We also process, receive and dispatch from 11 inbound and outbound international commercial carriers."

Through the process of monitoring and verifying all these pallets, the squadron processes an average of 4.5 million pounds of mail, shipping to 578 world locations in support of 160,000 deployed personnel throughout the AOR, said Cervantes.

The mail is then taken from the airport to a Joint Military Mail Terminal, where it is X-rayed and inspected to ensure there are no prohibited items being shipped, she explained. Next, the mail is sorted by zip code, palletized and then loaded onto

a truck.

Up to two of these trucks head to the 386th each day, where they are offloaded by post office contractors and sorted with the help of volunteers from around base, said 1st Lt. Venkatesh Kamath, the 386th Expeditionary

Communications Squadron plans and resources flight commander.

The mail on these trucks includes letters and packages not only for the 386th, but other branches and coalition partners around base as well. Sometimes this mail can be for

geographically-separated units operating in austere locations, Kamath said.

Getting mail to all these entities can pose a problem considering the confined space in which contractors operate, he explained. For now, they have an organized process in place to make the most out of the small space, but as the base continues to grow, they'll begin to look for ways to grow the space as well.

"One of the projects we're working on right now is to expand the postal facility," Kamath said. "We hope to increase the size of the post office so that it's more helpful for contractors over here and so they have more room to store the mail and break it down."

Although personal letters and care packages make up a large portion of the incoming mail, it's not the only reason for having a post office on base. Mail can also serve as a means for ensuring deployed members are able to continue performing their civic duties while serving their country abroad.

## AF uses drone for inspection

**EDWARDS AIR FORCE BASE, Calif.** — The 412th Test Wing's Emerging Technologies Combined Test Force used a quadcopter to conduct a maintenance inspection of the exterior of a C-17 Globemaster III here March 6, 2017.

The C-17 was on loan from Joint Base Lewis-McCord, Washington. It was the first time the CTF flew a small unmanned aerial system on the flightline and the second time the CTF has used a sUAS in a new application that shows promise.

The winds remained manageable and allowed the test team to conduct three sorties with the quadcopter, which was fitted with a video camera. Live video was assessed by the team that included maintainers, to determine if the quality was adequate for routine inspections. The video recorded from the quadcopter's camera will be analyzed to see if it is clear enough to see smaller details of the cargo plane's exterior such as structural abnormalities, rivets and cracks.

Maj. Dan Riley, the CTF director said, the test was so successful that the maintainers used the data to sign off their preflight external inspection, a first for the Air Force.

"This could save (maintainers) a lot of time," said Staff Sgt. Joshua Jaburek, of the 62nd Aircraft Maintenance Squadron at JB Lewis-McChord. "When we

go on top of the airplane, we can only walk on certain parts and then we have to hook and unhook our (safety harness) very few feet."

Inspections that would normally take 45 minutes to an hour could be done just in a few minutes with a quadcopter if it's successful. Maintainers also would not need a lift to inspect a C-17's tail, Jaburek said.

Capt. Justin Merrick, a CTF lead engineer said, the CTF got the idea from seeing a video online showing a commercial airline company using a sUAS to inspect a plane.

"(Leadership) encourages us to go out and conduct tests, so after we saw some videos online we contacted some maintainers here and they were very

enthusiastic to help out," Merrick said.

Riley added that this first test on the flightline could pave the way for future sUAS tests and test procedures.

"Another reason we've conducted this test is to open the aperture on flying a sUAS near the airfield, which has been frowned upon in the past," Riley said. "As we execute these missions it establishes a baseline for how operations can be conducted safely, not only here at Edwards, but at other bases as well. We couldn't have accomplished what we have so far without the support of the 412th Operations Group and test wing commander in breaking down some of the barriers to these types of operations."

## Squadron revitalization leads to EPME changes

**WASHINGTON** — The reenlistment and extension ineligibility requirement will be removed from the enlisted professional military education program effective March 15, 2017 according to Air Force officials.

Air Force deputy chief of staff for manpower, personnel and services Lt. Gen. Gina Grosso, approved the change, removing the automatic reenlistment or extension ineligibility status for Airmen who fail to complete their enlisted professional military education distance learning course tests by their suspense date.

"We continually review and evolve personnel policies to ensure it provides equity for Airmen, aligns with our Air Force strategy and supports our Airmen's ability to execute the mission," Grosso said.

"While originally intended to drive increased development and professionalism, the previous EPME approach created a higher standard, particularly when compared to recent changes to our officer PME model. Additionally, as we grow the force the policy added unnecessary challenges and distractions to our Airmen. We certainly heard and listened to Airmen on this matter."

The former policy stated that if an Airman exceeded the

suspense date for course completion, the Airman automatically became ineligible for reenlistment or extension, until the course was complete. This meant impacted Airmen were required to separate or retire on their date of separation. Although PME completion is expected and tied to promotion, non-completion is not directly tied to continued service under the officer system. This change brings both systems back into alignment.

The need for this policy change was confirmed during the Air Force Chief of Staff's Squadron Revitalization effort. "Airmen clearly identified this as an issue in both the Air Force Revitalization Survey and during the recent field interviews conducted at Joint Base Andrews," said Brig. Gen. S.L. Davis, Team Lead for the squadron revitalization effort.

The policy adjustment places authority and responsibility for reenlistments back at the squadron level and provides flexibility for commanders to retain high-performing experienced Airmen who meet the Air Force's mission needs, in line with revitalizing Air Force squadrons.

"As we work to revitalize our squadrons, it remains important that commanders and supervisors who are closest to an Airman have a say in whether or not an Airman should be allowed to re-enlist," said Grosso.

it wasn't because he was cold.

"The water wasn't cold," she explained. "So I put him over so he could expel whatever was in his throat. Then, he coughed up a bunch of water. My nursing training kicked in."

She took his pulse and checked his ABCs: airway, breathing and circulation.

"I made sure he was OK," said Water. "He kept saying he was dizzy, his arms were dizzy and he was extremely tired."

It was quite a distance to his family over rough terrain, so they couldn't carry him, Thomas said. Since he was unable to walk, they waited with him.

"We waited until he could breathe a bit better and his pulse was in a normal range," Waters said. "When he said he was OK, Dante and I swam back with him on our shoulders to his family."

The family had no clue what had almost happened, Thomas said. They were incredibly grateful.

For the two Citizen Airmen, personal and professional instincts kicked in fast.

"The first thing that went through my mind was my son; I have a son the same age," Waters explained. "It was almost immediate, like a mother's intuition."

Thomas said that as a police officer, he is always aware of his surroundings.

"I was just enjoying the scenery and saw something that didn't add up," he said. "I went from enjoying the scenery to seeing his head bob."

The two Citizen Airmen don't see what they did as anything out of the ordinary.

"I just did what I was supposed to do," Thomas said. "It's like putting on the uniform. We didn't do this to be recognized. It was just - something's wrong here, let's do what we can to make it right."

Water's echoed his thoughts.

"I think as a security forces member, it's not that huge of a deal," she said. "We know that any one of us, had we been in that situation, would have done that exact same thing."

in Washington, D.C. As part of his responsibilities, he led the development and integration of the Air Force strategy, long-range plans and operational capabilities-based requirements to ensure the Air Force built and employed effective air, space and cyber forces to achieve national defense objectives.

Holmes commissioned through Officer Training School in 1981 after receiving a degree in electrical engineering from the University of Tennessee. He is also a command pilot with more than 4,000 hours, including more than 500 combat hours in the F-15A/B/C/D/E Eagle, and has also flown the T-38 Talon, T-37 Tweet and T-1A Jayhawk.

This will be Holmes' fifth

assignment within ACC. He previously served as the commander of the 27th Fighter Squadron from May 1999 to July 2000.

"We now face new and revised challenges from both great and regional powers who threaten the survival of our American experiment, seek to isolate us from our friends and allies and hope to redefine the world on their terms," Holmes said. "Our success and survival as a nation in the face of these threats are not guaranteed. It depends on all Americans to uphold ideals and make our union more perfect, but certainly depends on the capabilities you bring as part of a joint team. Yes, it's a dangerous world and it grows more dangerous every day, but we will not be afraid, we will instead be ready. We will be ready to deter our enemies by demonstrating with certainty that we can defeat them."



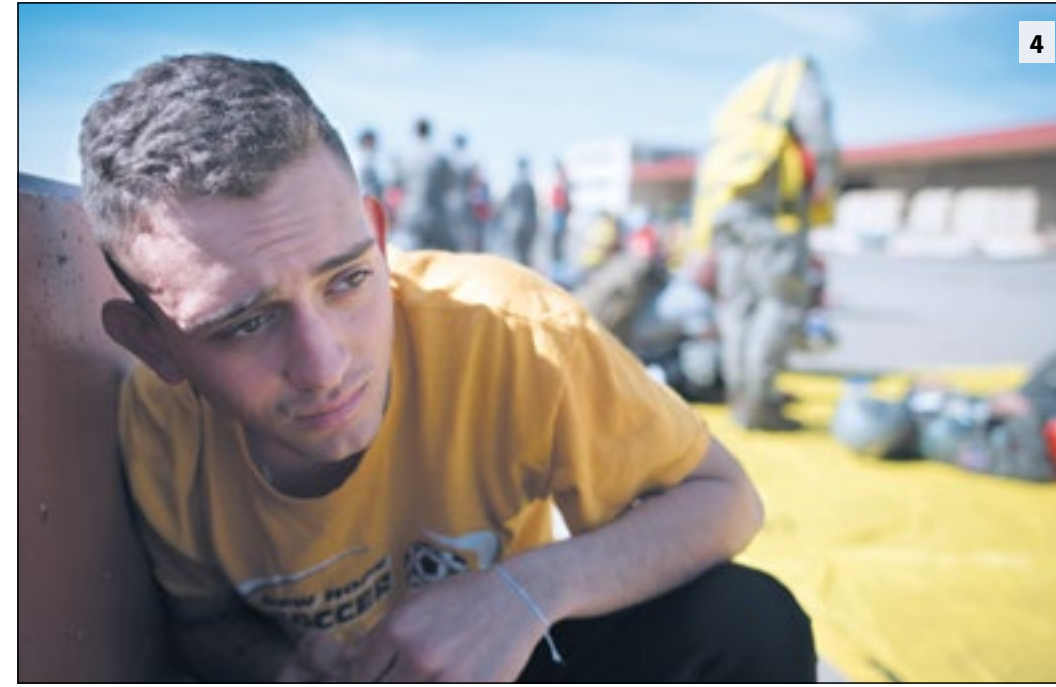

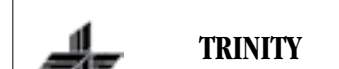

creativity to make the right decisions and capture innovative efficiencies. The past couple generations have been taught to question why decisions are made and that is a good thing, within reason. A wise person once told me those who understand how things are done will always work for people who know why. Several new Air Force policies have generated questions, especially about Enlisted Force Distribution Panels, Enlisted Performance Reports

and promotion boards. It's in this un-chartered territory where junior Airmen struggle. I contend your record will speak to your leaders. You need to trust them and the system.

Perhaps this is where faith comes in. Faith generally enters when you can't see something. I agree, but I also contend that faith is actually seeing something or someone, in action. I'm talking about the leaders appointed over you. They see your record and what you do. They consult up and down the chain of command. They are part of a system.

The beauty of systems is their success does not lie within one, but the whole.

Think New England Patriots, San Antonio Spurs or Los Angeles Lakers of old. They won with systems. We are privileged members of one of the greatest military systems in the world – the U.S. Air Force successful since Sept. 18, 1947.

BMT's madness may have seemed strange, but now it makes sense. BMT will continue to do the same for many future American Airmen. The changes taking place in our system now have a certain genius about them. Just stay the course, trust your leaders and have faith in the system. One day, young leader, you get to explain your Air Force's decisions to your Airmen.

also cause for concern, as the current fiscal year's National Defense Authorization Act seeks changes to financial benefits – specifically basic allowance for housing.

"This would reverse nearly 20 years of deliberate legislative action to ensure service members are appropriately compensated for their service, and that their salaries remain competitive with private-sector professionals," said Wright.

Similarly, today LaRivee's career field is manned with just over 5 percent women.

"Not every little girl grows up dreaming to be a pilot," said LaRivee. "It's not a common perception for women to be in flying in general, let alone for women to be in the military."

While at the academy, she had an opportunity to fly gliders. She recalled how she felt in control of her own exhilarating roller coaster ride. After that, she was committed to make it as an aviator.

"There are still biases out there, and sometimes there are people who make assumptions," said LaRivee. "They're not so sure you can be as qualified as a male pilot, but that just makes you want to work even harder to show you're just as capable."

"In aviation, it doesn't matter if you're male or female- you're a flyer," said Barbara Brewer, 21st AS unit program coordinator. "Your gender doesn't change that ability."

The world of 2017 has progressed socially far beyond the

views of 1976.

"My mother faced a lot more challenges and a lot more barriers," said LaRivee. "There were not as many women who had gone before her to pave the way to prove that women were just as capable as men if they worked hard at it."

LaRivee views her gender as a proud part of her identity. She is aware of the obstacles being a female military member presents, and accepts them as an opportunity to excel beyond expectations.

"You can't pretend that we are built the exact same way as men. But, there are so many ways that we can, if not overcome it, become better," said LaRivee.

Trials arise throughout a military career that tests a person's confidence in their own ability. While flying a mission, LaRivee was part of a predominately female crew. She remembers a passenger looked inside the flight-deck and was shocked that he had been unable to tell the difference in women flying the aircraft rather than men. This comment did not bring LaRivee to question her capacity as a woman, but rather solidified her confidence in her skill.

"If you face challenges, don't let them get you down, let them inspire you to do better," said LaRivee. "There are so many women in aviation who have done amazing things, and there have always been people who doubted them."

In a 1996 speech made by LaRivee's mother, the message of femininity in the military rang out.

"One of the biggest challenges of being a woman in the military has and will continue to be balancing strength with sensitivity, confidence with humility," said retired Lt. Col. Marianne LaRivee, in a speech presented at the Senior Executives Symposium Spouses Program. "We want to show that we can do our jobs well while also staying true to ourselves as women--daughters, sisters, and mothers. That we can do what our country asks of us while also living up to the cultural expectations and responsibilities of our gender."

The Air Force perseveres in its commitment for a brighter, more diverse future.

"We've made a lot of progress in the last 40 years," said LaRivee. "The social norms have improved so much in our favor as women in the military."

Air Force justified its decision. In *Torcaso v. Watkins*, 367 U.S. 488 in 1961, the Supreme Court found that requiring a "declaration of belief in the existence of God" as a qualification for public office was unconstitutional. Although a candidate has the option of not pursuing public office, requiring such a religious

test is still an encroachment both on Article VI of the Constitution and the Free Exercise Clause of the First Amendment.

In a controlling memorandum opinion, the general counsel of the Department of Defense used the foregoing court case, among others, to justify changing the oath policy. They stated in part, that requiring "so help me God" as a condition of enlistment or officer appointment is an infringement of one's constitutional protections.

With this 2014 decision, the Air Force joined the other services in their oath practices.

It is important to not only give our Airmen the option of making a secular oath, but also to explain why the Air Force made the change. Understanding the reasoning behind this decision can better allow us to address other instances where First Amendment freedoms - religion, speech, press, assembly and petition - are in question.

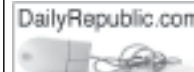
